Brief description of goods or services required:	The Shire of Corrigin is offering a six year agreement with an initial term of three years and an option for a further three years in return for the provision of a General Practitioner and associated medical services to the Corrigin community		
Particulars of the decision to invite tenders:	<p>The Shire of Corrigin received advice from WALGA Governance Division and Department of Local Government confirming that a tender was required for medical services for the following reasons:</p> <ul style="list-style-type: none"> <li>Continuing the arrangement beyond the current expiry of June 2020 without a public tender process, will breach tender requirements under s.3.57 and the Functions and General Regulations.</li> <li>The unique purchase provisions cannot be applied as other Doctors in the market may wish to bid for the opportunity.</li> <li>The Shire risks the continuing non-compliance being identified in an audit or through community or a regulator scrutiny.</li> <li>There is an inherent financial risk for the Shire having not substantiated that the continuing payment of public money for the annual \$50k incentive (or at a lesser \$value) is necessary for the financial sustainability of the practice.</li> <li>There is a reputational risk for the Shire (and for the Doctor) if the non-compliance continues and becomes a matter of public interest, audit or inquiry.</li> <li>The Shire should not continue the current MOU beyond agreed June 2020 expiry and should undertake a public tender process that assesses qualitative criteria, to which the current supplier and any other potential supplier may respond.</li> </ul> <p>Local Government Act 1995 s 5.42 Delegation of some powers to the CEO S5.43 Limitations of delegations to the CEO Council has delegated the CEO authority to call tenders (F and G r11.1 (1).</p> <p>Value of medical services is included in the 2019/20 budget and Long Term Financial Plan.</p>
