### Spring Cleaning

The new banners along Walton Street provide a welcoming entry to the town and the gardens have been freshened up and weeded. The birds seem to be enjoying the warm weather and I have seen them and heard their cheerful noises all over town.

The main street is looking great with the new planter boxes, bollards and bins and we have received many positive comments from locals and visitors. A new table and seating area is still to be installed under the shade sails and the finishing touches are expected to be completed soon.

**I can't wait for the new trees in the planter boxes to burst into flower and for the roses in the rose garden to put on their usual colourful display.**

Our talented local photographers have been filling the social media pages with our amazing native orchids and colourful wildflowers as well as images of our beautiful sunsets and golden canola crops.

Over the past few months Roe Tourism, Pathways to Wave **Rock and Australia's Golden Outback have been promoting** weekend road trips to the area. During July the friendly hospitality at our local country pubs in the region were featured in a series of social media posts. The golf courses in the neighbourhood featured during August along with the stunning wildflowers on show during the month. I encourage everyone to check out these facebook pages and like or share the posts to spread the word about our local attractions.

While on the topic of promoting our local attractions - congratulations to Mains Guest House for making it to number three on the RAC list of the 10 best farm stays in WA.

### Rotary Park Redevelopment

The draft Concept Plan for the Rotary Park Redevelopment is expected to be ready in a couple of weeks and we look forward to sharing the plan with you and hearing your feedback before the plan is finalised.

The plan for the park redevelopment is to include a new toilet block, playground and parking area along with gardens showcasing local native plants. It is hoped the improvements to the main street along with Rotary Park will provide a more attractive and welcoming experience for visitors to our town.

### CREC Roof

I recently attended a meeting with the shire lawyers regarding the ongoing issues with the leaks in the roof of the Corrigin Recreation and Events Centre (CREC). The CREC roof is the subject of legal action in the Supreme Court between the builder and roof manufacturer.

A range of options have been presented to the Shire of Corrigin but until we receive further specialist architectural and engineering information on the long term impact of the options, the Council is not in a position to make any definite plans on the future of the roof.

The Shire of Corrigin has been advocating strongly for a resolution to the legal action as soon as possible and will continue to push for an outcome by the end of the year.

### Out on the Roads

With the adoption of the budget last month it has been full steam ahead out on the roads. The graders have been out on as many roads as possible while the moisture lasts.

In addition to the usual maintenance program Council set a large construction program for the crew this financial year with approximately \$800,000 to be spent on resealing, shoulder widening and floodway repairs. An additional \$1.2m has been budgeted to upgrade and widen approximately 8 km of bitumen roads in the shire.

Work has started on widening the shoulders of the Babakin Corrigin Road before the machines head over to the Corrigin Quairading Road and then on to the Bendering Road.

### Pre Harvest Breakfasts

I am looking forward to the pre harvest breakfasts that are planned for 12-15 October at Bilbarin, Bullaring, Bulyee and Gorge Rock. It will be a great chance to get out of the office and chat to everyone.

We also have our Staying @ Home photo's which the community rallied to participate in, thank you to Heather and the CRC staff for the initiative to have the photo's made into banners for Walton Street. Photo's for our future history, fantastic initiative.

The Council wish to acknowledge the commitment by Mrs Caley and Mrs Manton for bringing the Council budget forward by one month to be adopted in the July Council Meeting. This has been a commitment by Mrs Caley to have this done, with the adoption in July a positive aspect for the shire. With the budget finalised, means that the rates have been sent out, the zero rate and fee's increase will make a difference for many. We thank all of the rate payers that have paid to date.

This year we have a very exciting budget. With the addition to our road programme we have new Aged Housing, Rotary Park redevelopment, new Caravan Park abluion block and the addition to the Wellness Centre planned for later in the budget. This will keep all of our staff very busy.

In the October Council meeting 2019, a policy was passed for the maintenance of our gravel road system. The importance of this policy is to manage the way our road maintenance is to be delivered to the rate payers. We will all have noticed a change in the way the roads have been prepared and finished, the focus of the policy, is to focus our gravel road maintenance during the winter period. We still have a long way to go but the policy is set to improve the road programme for the future.

We all notice the vibrance of our town, but the importance of this buzz is the volunteers that work within our community every day. We would struggle to have a community with no volunteers. Thank A Volunteer breakfast was had at the CREC to recognise some of the work done by our volunteers. 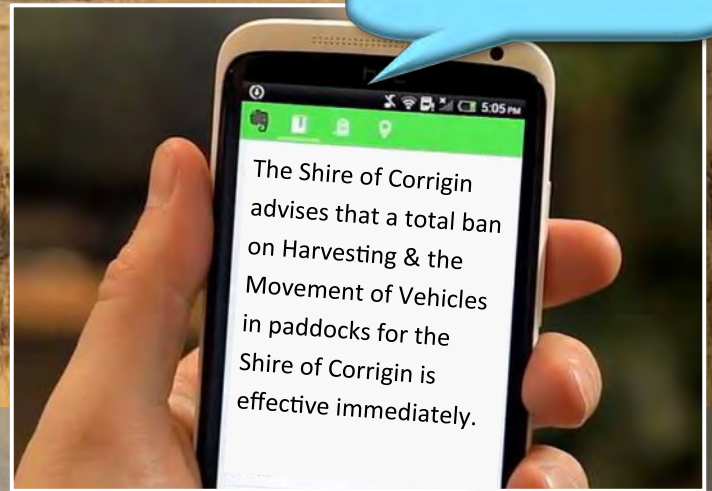

## Shire of Corrigin Firebreak Order 2020/2021

Pursuant to the powers contained in Section 33 of the *Bush Fires Act 1954*, you are hereby required to install firebreaks clear of all flammable material or take alternative approved measures, and to undertake fuel hazard reduction measures before 31 October 2020 and thereafter maintain free of all inflammable material until 15 April 2021.

### 1. RURAL LAND

1.1 *Mineral earth firebreaks* of not less than 2.44 metres (8 feet) in width must be constructed along and within 20 metres of all external boundaries of the property owned or occupied by you. If any portion of the land adjoins a public road or railway line, a firebreak must also be constructed along that boundary.

1.2 Property in excess of 250 hectares shall have *mineral earth firebreaks* positioned as necessary to divide land into areas not exceeding 250 hectares each completely surrounded by a *mineral earth firebreak*.

1.3 Clear and maintain *mineral earth firebreaks* at least 2.44 metres (8 feet) wide within 20 metres of the perimeter of any building or group of buildings, fuel tanks, hayshed or haystack, in such a manner as to fully encircle the structure/s. In addition to *mineral earth firebreaks*, a 20 metre wide low fuel zone is required to be maintained around any building or group of buildings, fuel tanks, hayshed or haystack. Low fuel means the removal of inflammable material, dead trees, leaf litter and trash and the removal of dead branches to a height of 1.5 metres from live standing trees. Grass is to be slashed to a height not exceeding 100mm.

1.4 During any period when harvesting operations are being conducted, there shall be provided an operational mobile firefighting unit with a minimum capacity of 500 litres of water located in or immediately adjacent to the paddock being harvested. The responsibility to supply the unit is that of the landowner/occupier.

### 2. TOWN SITES

2.1 Where the area of the land is 0.2 hectares (one half of one acre) or less, you shall clear all inflammable material on the land from the whole of the land.

2.2 Where the area of the land exceeds 0.2 hectares (one half of one acre), you shall clear of all inflammable material, *mineral earth firebreaks* not less than 2.44 metres (8 feet) wide immediately inside all external boundaries of the land, and also immediately surrounding all buildings, haystacks and fuel ramps situated on the land, and also immediately surrounding any drums or drums situated on the land which are normally used for the storage of fuel, whether they contain fuel or not.

### 3. GENERAL PROVISIONS

The term **"inflammable Material"** or the purpose of this notice includes bush (as defined in the Bush Fires Act 1954), timber, boxes, cartons, paper, and the like inflammable materials, rubbish and any combustible matter, but does not include buildings, green standing trees and bushes or growing bushes or plants in gardens or lawns. If it is considered to be impractical for any reason to provide *mineral earth firebreaks* in the position or adhere to the provisions required by this notice, the written approval of Council or a duly authorised officer must be obtained to prepare such *mineral earth firebreaks* in an alternative position. If permission is not granted by Council or a duly authorised officer you shall comply with the requirements of this order.

The term **"mineral earth firebreak"** means an area of the owner(s)/occupiers(s) land, cleared and maintained totally clear of all vegetation material (living or dead) so there is only mineral earth left.

The term **"harvesting/total movement ban"** includes harvesting and the movement of vehicles in paddocks, except vehicles carrying water to stock.

Contractors carting lime, gypsum or fertilizer are allowed to enter into paddocks to **unload at any time that there is a "harvest/total movement ban"** in place on the condition that a manned fire unit with at least 500 litres of water is in attendance.

### 4. HARVEST / MOVEMENT OF VEHICLES BANS

TOTAL FIRE BANS may be imposed by DFES on a regional basis on days of severe or greater fire danger. Activities which may cause a fire are prohibited. Harvesting/movement bans may also be imposed by the Shire. Harvesting is not **permitted on Christmas Day, Boxing Day and New Year's Day**.

### 5. ADDITIONAL RESPONSIBILITIES AND PENALTIES

The penalty for failing to comply with this order is a fine of not more than five thousand dollars (\$5000) and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work directed by this notice, if it is not carried out by the owner or occupier by the date required by this notice. In addition, Council can arrange for the required work to be carried out at the cost of the owner or occupier. Gas or electric barbecues ONLY are permitted during prohibited burning periods. No solid fuel or wood barbecues allowed. Camping and Cooking fires are prohibited during the prohibited and restricted burning periods unless a valid permit has been issued by the Chief Bush Fire Control Officer.

Permits for burning during the restricted burning period are available from your local Bush Fire Control Officer. Burning is not permitted during the restricted burning period and public holidays or during Easter when Easter falls within the restricted burning period. Persons burning without permits during the restricted burning period or on days when a very high or greater fire weather warning has been issued may be prosecuted. Prior to any burning, you are required to notify your neighbours, Bush Fire Control Officer and the Shire of Corrigin. Besides being responsible for the safety of your own property, if a fire escapes from your property you may be liable to pay compensation for any damage caused outside of your property. Public infrastructure must not be placed in a manner that results in an above-ground encroachment into the firebreak area. Trees must not be planted in a manner that results in vegetation encroaching into the firebreak area.

### 6. BURNING PERIODS

RESTRICTED BURNING PERIOD - Permit to burn required from a Bush Fire Control Officer from 19 September 2020 to 31 October 2020 and from 16 February 2021 to 15 April 2021.

NO BURNING PERMITTED (INCLUDING CAMP FIRES) - From 1 November 2020 to 15 February 2021.

### 7. BUSH FIRE CONTROL OFFICERS

Shire of Corrigin Bush Fire Control Officers are authorised to issue permits to burn on private land during the restricted burning period. Bush Fire Control Officers are also empowered to enter land and issue directives relating to fire suppression and control.
