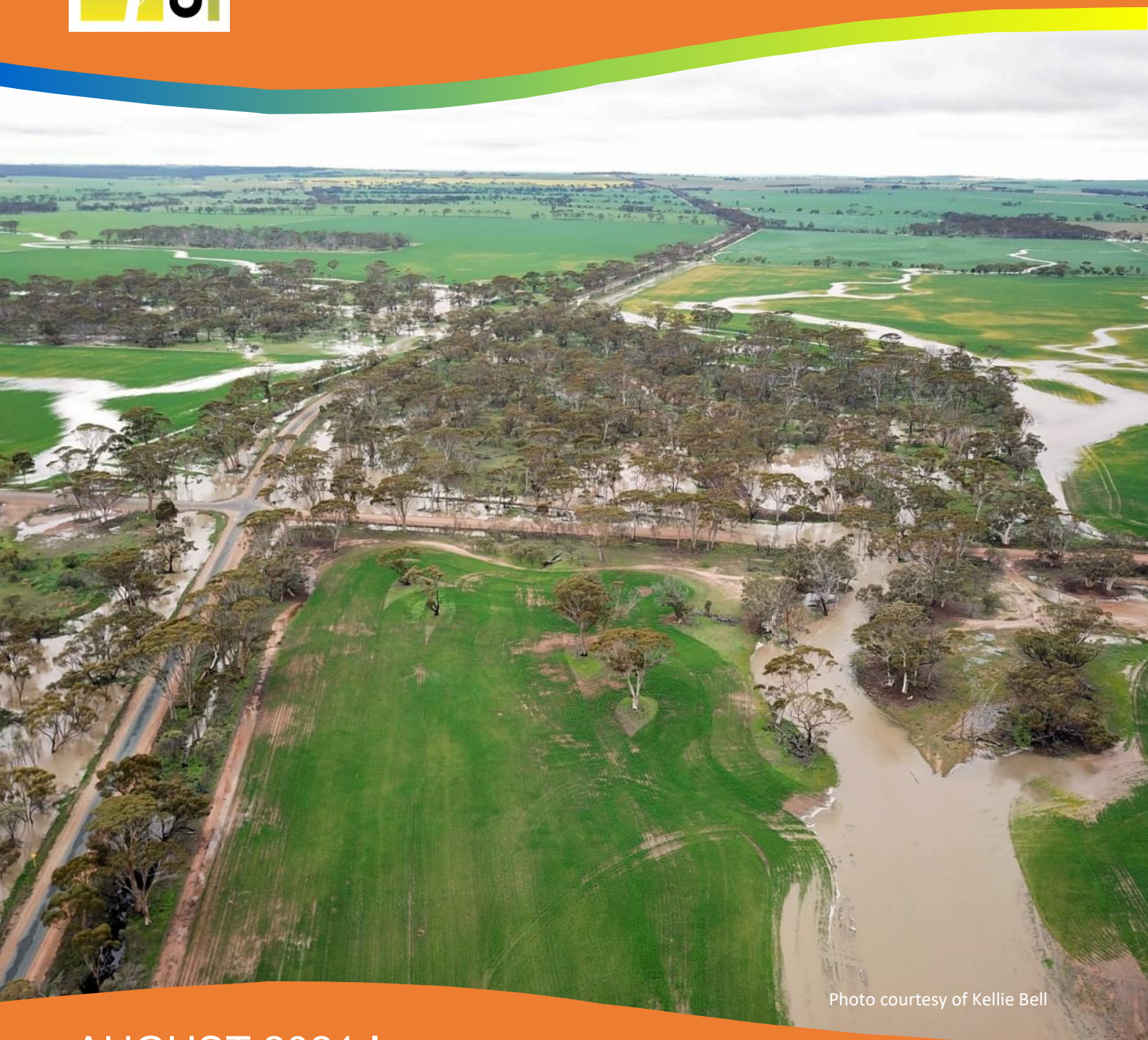

# CEO's Corner

Wow it has been wet out on the roads over the last week and our team have busy assessing damage to our floodways and making them safe.

## **CLOSED ROAD means CLOSED ROAD**

Unfortunately we have found many motorists have been ignoring ROAD CLOSED signs and several of our warning signs and cones have been removed. This is extremely disappointing and puts road users at risk, especially when driving at night. Penalties apply to anyone who ignores or removes road closed signs.

Driving in flood water can be extremely dangerous so please:

- Follow all signage, it is there to keep you safe
- Drive to the conditions
- Stay alert for any potential hazards
- Plan your trip as detours may be required

Please be patient with us as we work to reopen roads as soon as possible.

As we assess the damage to our roads network and floodways we will gather information to make a claim for funding to repair the damage.

## **Old Road Boards Building and Town Hall**

We were so pleased with the restoration of the interior of the Town Hall last year that we have allocated funds in the budget to paint the exterior of the hall and restore the Old Roads Board building.

Tenders closed last week and we will evaluate the tenders and expect to appoint the successful contractor at the next Council meeting. It is hoped that work will be finished by the end of the year.

## **Fox Baiting**

We have received a couple of calls about an increase in the number of foxes in shire managed reserves. I would be interested to hear of any farmers or contractors who are accredited to deal with foxes since we don't have any staff who are trained to use baits.

## **Budget Adopted**

At the last meeting Council adopted the budget which included a large capital works program. Our team did a great job getting through a huge amount of projects last year and will again this year. It seems ironic that we will be working hard to spend our drought funding at the same time as fixing roads during a flood.

## **Building and Planning Permits**

Working out if you need a building or planning permission can be difficult to understand.

We have noticed a few unauthorised buildings in Corrigin and people may not be aware that a building and or planning permit is required. If you are not sure if a development application or building permit is required please contact the shire office for assistance.

**Planning** - is about the permitted land use and details can be found at [www.dplh.wa.gov.au/corrigin](http://www.dplh.wa.gov.au/corrigin)

The Town Planning Scheme outlines the permitted, discretionary and excluded activities on the land and is divided into the following zones:

- Residential Zone
- Commercial Zone

- General Industry Zone
- Rural Zone
- Rural Residential Zone

**Building** - is about the structural integrity of any building.

A building permit is required before you do any building work including new construction, alterations or extensions of existing buildings, regardless of how minor the building work is unless otherwise exempted.

Temporary buildings that will be on site for less than 1 month do not need building permit.

Some kinds of building work do not require a building permit include small garden sheds, temporary site sheds, certain fences (other than a fence forming part of an enclosure for a private swimming pool), certain masts and antennas, small retaining walls, small pergolas and the like.

A building permit is not required for building work for Class 10 buildings or incidental structures in the whole of the Shire of Corrigin (any many other shires) other than the townsite. This means that class 10 buildings on farms do not require a building permit including non-habitable buildings or structures such as a private garage, carport or shed.

Septic tank approvals and demolitions are separate processes and involve the Environmental Health Officer

# July 2021 Council Decisions

## **BUDGET ADOPTION 2021/22**

Council adopted the Shire of Corrigin Budget for the 2021/22 financial year together with supporting schedules, including imposition of rates and minimum payments, adoption of fees and charges, establishment of new reserve funds, setting of elected member's fees for the year and other matters arising from the budget papers.

## **CHANGE OF ORDINARY COUNCIL MEETING DATE 2021**

The advertised date of the September Council meeting is Tuesday 21 September which clashes with the date of the WA Local Government Convention. Council have resolved to change the date of the September Ordinary Council meeting to 16 September 2021 at 3:00pm

## **PROPOSED LOCAL LAWS – CORRIGIN WAR MEMORIAL SWIMMING POOL REPEAL**

Council resolved to proceed with the proposed *Shire of Corrigin War Memorial Swimming Pool Repeal Local Law 2021* as it is no longer relevant or required.

## **LEASE AGREEMENTS WITH LOCAL SPORTING/CULTURAL GROUPS**

Over the past eighteen months the administration have been working towards entering into lease agreements with all community organisations that currently have the use of buildings on Shire managed Crown Reserves.

Council have now entered into lease agreements with the Corrigin Historical Society Incorporated, Corrigin Tennis Club, Australian Red Cross Society, Corrigin Golf Club, Corrigin Bowling Club, Rifle Club and Corrigin Creative Arts Club.

## **LOTTERYWEST BUILDING GRANT AGREEMENT – CREC**

In 2013 Council was successful in receiving funding of \$363,636 towards the construction of the Corrigin Recreation and Events Centre from Lotterywest. As part of the funding process at the time the Shire was required to enter into a Building Grant agreement with Lotterywest for a period of ten years.

Lotterywest have recently reviewed its policy towards retaining a beneficial interest in buildings purchased or renovated using grant funds. As an outcome of that review, Lotterywest has decided to relinquish its beneficial interest over the Corrigin Recreation and Events Centre.

Council endorsed a Deed of Termination for co-signing to progress the matter to finalisation.

## **NEW POLICY PORTABLE AND ATTRACTIVE ASSETS**

Council adopted a new policy to establish guidelines on the management and recording of portable and attractive assets under the capitalisation threshold and that do not form part of the Asset Register.

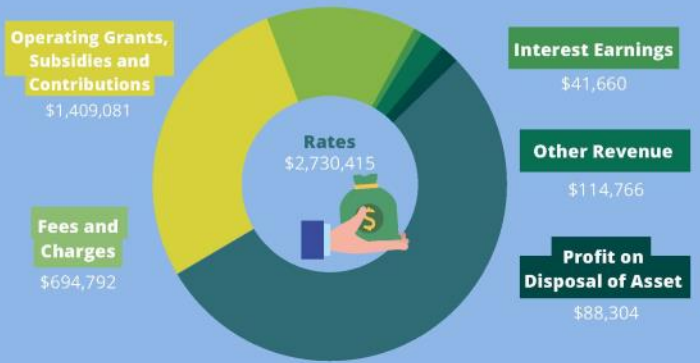

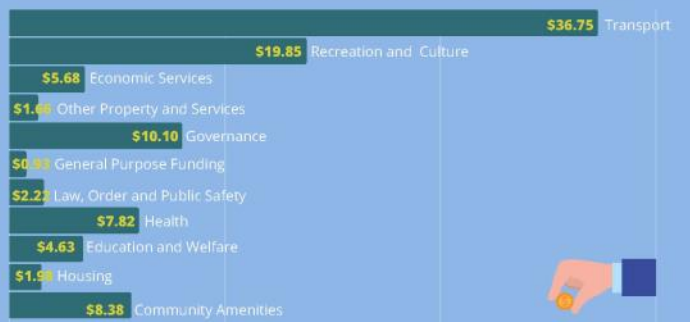

## HOW YOUR RATES ARE CALCULATED

Rates are calculated based on the rateable properties within the Shire and are valued by the Valuer General (Landgate) using two methods:



Unimproved Valuation (UV) for rural properties and Gross Rental Value (GRV) for town properties. Landgate undertake a valuation of UV rated properties on an annual basis and GRV rated properties are valued every three to five years. The overall increase in rural property valuations for the 2021/22 year was 13.28%.

The valuation is then multiplied by the rate in the dollar set by Council which can vary from year to year, depending on the total amount of rates to be raised. If the total calculation is less than Council's minimum rate, the minimum rate applies.

### Rate Due Dates and How To Pay

The Shire provides two options for payment of rates:  
**OPTION 1 - Payment in full prior to 4.30pm on 3 September 2021.**  
**OPTION 2 - Payment in four instalments**

1st Instalment - Due 03.09.21    2nd Instalment - Due 03.11.21    3rd Instalment - Due 03.01.22    4th Instalment - Due 03.03.22

Payment of rates via Option 2 will result in the following:  
 Administration charge - \$10 per instalment  
 Instalment interest - 5.5% per annum

Payments can be made in person at the Shire of Corrigin, 9 Lynch St, Corrigin by cheque, cash, credit card or EFT. Payment can also be made online by visiting the Shire's website at [www.corrigin.wa.gov.au](http://www.corrigin.wa.gov.au) and clicking Pay Online. Please ensure time is allowed for postage and clearing of funds at the bank to allow payment to be received by the Shire on or before the due date. Payments must be received by 4.30pm on the due date to avoid penalties being applied.

### Penalty Interest Charges on Overdue Rates

Under the Local Government Act interest is charged on overdue amounts. Council has set the interest rate at 7% per annum which will be applied to all amounts outstanding after the due date of the rate notice. Penalty interest accrues daily until all overdue rates and charges are paid in full. Eligible pensioners are exempt from interest charges.

## Local Government Rates Rebate

Pensioners/Seniors Concession Scheme provides pensioners and seniors with a rebate or deferral of their local government rates charges and emergency services levy.

To qualify for a rebate, you must own and occupy your house as at 1 July each year.

To own means an applicant must be the registered owner or co-owner of the property on the Certificate of Title.

And you must be a holder of a valid:

1. Pensioner Concession Card issued by Centrelink/Veterans Affairs (50% rebate); OR
2. WA Seniors Card issued by the Office of Seniors Affairs AND a Commonwealth Seniors Health Card (50% rebate); OR
3. State Concession Card (50% rebate); OR
4. WA Seniors Card only (25% rebate);

Applications for these rebates can be made by phoning the Water Corporation who administer the rebate scheme

on 1300 659 951 or provide an online application via [www.watercorporation.com.au](http://www.watercorporation.com.au)

The eligibility date will be that of your application lodgement date with the Water Corporation and can not be back dated.

### Financial Hardship

Council's Rates Collection and Financial Hardship Policy includes ratepayers in our community who may be suffering financial hardship as a result of life events that impact a person's capacity to pay their rates. Contact Rates Officer for assistance and an application form.

A successful application will result in a rates payment plan agreed between Council and the Ratepayer, who will make the agreed payment plan.

# CAPITAL EXPENDITURE HIGHLIGHTS

## Capital Investment

Capital works planned for 2021 - 2022 total \$7.2 million and will be funded by general revenue as well as State and Federal grants and contributions.

Expenditure on roads and footpaths is a major component of this year's budget amount to \$3.8 million. Council has also budgeted for a number of new community assets as well as improvements to existing community assets to ensure continual upgrade and asset prevention.





# HOW DO I DISPOSE OF ASBESTOS SAFELY IN CORRIGIN?



- 1 Visit or call the Shire of Corrigin office reception - 9063 2203.
- 2 Request an application for a contaminated waste disposal permit.
- 3 Fill out the application and return it to the Shire.
- 4 Your application will be assessed and a permit will be issued to you indicating the date of disposal and conditions of disposal.
- 5 Payment can be made through the Shire of Corrigin reception.

\*Please do not bring your asbestos load to the tip without a disposal permit as it will not be accepted. Asbestos containing waste will only be accepted on a mutually agreed date and time which will be outlined in your permit\*

\*If a load is deemed too large to be accepted for burial at the Corrigin tip, a permit for the Bendinger landfill will be issued

# DOG OWNERSHIP

## FENCING REQUIREMENTS

Dog owners must ensure that all fences and gates at the premises where the dog is kept are capable of confining the dog within those premises.

## NUMBER OF DOGS

- 2 dogs per Townsite premises
- 4 dogs per Rural premises



Exemptions can be granted through the Shire!

## DOG POO

If you have a dog you will need to be a responsible owner and pick up after it. It's the right thing to do to keep our streetscapes clean and tidy.

Penalty \$1000 or a modified \$100 fine.

# RV FRIENDLY TOWN

The Shire is pleased to announce that Corrigin has been named an RV Friendly Town, by the Campervan and Motorhome Club of Australia (CMCA).

It is estimated that the self-contained RV Tourism market is worth more than \$2.5 billion annually (CMCA) and the Shire of Corrigin believe that the town is well-positioned to capture this massive growth tourism market.

The program works to encourage a partnership between recreational vehicle (RV) tourists and the towns they visit, aiming to maximise the value of self-contained RV tourists to both metropolitan and regional Australia.

The Shire of Corrigin believe that by joining the RV Friendly Town network there will be direct benefits to local businesses and the wider community.

To qualify for the program, towns must successfully meet the needs of self-contained RV travellers and satisfy key criteria including:

- Access to a general shopping area
- Provision of appropriate low cost overnight parking for self-contained vehicles
- Access to potable water and a free dump point

With these amenities in place, RV tourists can access any RV Friendly Town in the knowledge they will be welcomed and well looked after.

The CMCA help to promote the towns RV Friendly status to their members and other RV travellers across Australia through the inclusion of an article in their club magazine the Wanderer, the CMCA website and social media.

At the May 2021 Council meeting, it was decided that a free 48-hour stopover area for self-contained RV's is to be established on south-west corner of Walton – Campbell Street intersection, behind the existing toilet block and RV Dump point.

In addition to the Walton Street location, longer term parking up to 72 hours will be established at Gorge Rock, Bulyee Hall, and Bullaring Tennis Club for self-contained RV vehicles only.

## COMMUNITY BUS HIRE

Council has a 24 seater Community Bus that is available for hire to residents. Non-residents are also able to make bookings, however residents will be given preference over the non-residents.

Drivers with a Light Rigid (LR) class licence or above are able to hire and drive the community bus. (Proof of licence will be required as part of the booking procedure).

The cost of the community bus is dependant on the kilometres travelled, but are charged at \$0.75 per km. It is the users responsibility to ensure:

- Sweep/vacuum and mop the inside of the bus
- Remove all rubbish and perishable items
- Wash and rinse the outside of the bus, especially if you have been on dirt roads
- Refill the fuel tank
- Fill in the Usage Form and return to the Shire Office

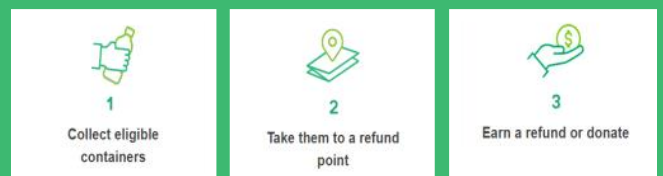
